Council, at its meeting held on 15th January 2019, agreed the following budget for events: -

1. YOUTH AWARDS

The purpose of the Youth Awards is to celebrate the achievement of young people under the age of 20 with a connection to Bishop Auckland.

There are no categories set initially, people are simply asked to nominate a young person who is worthy of a special award. The following examples are given as guidance, although nominations are not restricted to these examples.

Someone who: -

- Cares for friends or family members
- Has carried out an act of bravery
- Helped in their local community
- Has overcome their own difficulties
- Lives with an illness
- Achieved great things in sport, dance and drama or at school

All nominees are awarded a certificate. In addition, a number of young people, chosen by a panel of Councillors, will receive a Mayor's Medal and a framed certificate in recognition of their special achievement.

It is suggested that the current format, which has been in place since 2015, and proved very popular is continued.

Review of 2018 Youth Awards

Youth Awards presentation evening was held on 25th June, 6.30pm-8pm in the Town Hall. Approximately 160 guests were in attendance.

11 young people and 6 groups were awarded a certificate of achievement

4 young people and 2 groups were awarded the Mayor's Medal and framed certificate in recognition of their special achievements.

A new category of 'Team of the Year' was introduced with a prize of £500 awarded to the winning team. This generated interest from ten teams.

Youth Awards 2019

Date / Venue

Durham County Council has advised that the Town Hall will be unavailable from the end of May 2019 due to renovation work. The exact period of closure is not known. (N.B. the closure of the Town Hall will have an impact on most of the Town Council's events)

Options

- 1. Hold the presentation eventing earlier than in previous years so that it can be held in the Town Hall. A provisional booking has been made Wednesday 1st May 2019. This will ensure that the event has a familiar venue with technical support. This date will also avoid secondary schools' activities around GCSE's and prom activities.
- 2. Hold the presentation evening in June as in previous years at an alternative venue. Enquiries have been made with Bishop Auckland College.

Any alternative venue must have suitable technical and event support provided by the Town Hall.

Format

Suggested that the same format as 2018.

- All nominees to receive a certificate of achievement
- A number of young people, chosen by a panel of Councillors, to receive a framed certificate with the Mayor's Medal in recognition of their special achievement.
- Team of the Year award £500

2. HORTICULTURAL AND PRODUCE SHOW

Review of 2018

- Held on 28th and 29th September in the Town Hall.
- 40 show classes in total advised by the 'Growers Organising Group'
- Participation and quality of children's classes was overwhelming, mainly due to the hard work of Tam Mayor, Community Worker at The Auckland Project.
- Co-ordination with Bishop Celebrates Together worked particularly well.

Arrangements for 2019

Date / Venue

Bishop Celebrating Together event has been arranged for Friday 27th and Saturday 28th September. It would be beneficial for the Horticultural and Produce Show to be held on the same time, however this will need to be discussed and agreed with the growers organising group.

In addition, as the Town Hall will be unavailable, a suitable venue will have to be found in the vicinity of the Market Place. This will need to be accessible on a Friday evening through until a Saturday late afternoon. Location is key, not only for public attendance but also parking for drop off and collection.

The venue will need to have the same technical and event support provided by the Town Hall.

Access for 140 trestle tables including their set up would need consideration,

as well as site security, staff, access to refreshments and toilet facilities and the overall ambient temperature of the building. This will undoubtedly all incur additional costs compared to previous years.

3. REMEMBRANCE SUNDAY

Review of 2018

- Took place on 11th November 2018 marking the centenary of the end of the First World War
- Attendance: in the region of 2,000. A demonstration to the strength of feeling and respect for the occasion by the people of Bishop Auckland.
- Parade from Newgate Street into the Market Place was organised by WO Eastwood, 8
 Rifles. As well as the 8 Rifles organisations such as the 2505 Air Cadets, TA Cadets,
 DLI Association, veterans and the general public to part in the parade.
- Rev Keddilty, St Anne's Church lead the service at the cenotaph and the Church service.
- Wreath laying and event control was managed by the Town Council.

Arrangements for 2019

Remembrance Sunday will be held on 10th November 2019

This event is organised in close association with the Royal British Legion, 8 Rifles, Bishop Auckland Pipes and Drums and St Anne's Church. It is suggested that discussions be held with representatives at an early stage to co-ordinate the 2019 Remembrance Service.

In terms of event management organised by the Town Council, Durham County Council's Event Health and Safety staff have advised that given the size of the crowd in 2018, and taking into consideration the growing popularity of the service, it is advisable to have trained stewards on site to help with crowd management.
