### FIN 81/12 BUDGET FOR 2013/2014 - SECOND DRAFT V2

A copy of a Second Draft V2 of the Budget for 2013/2014 had been circulated.

Since this draft had been prepared, members were made aware of the following:

- Bishop Auckland Community Partnership Rent increase of 8% (£619 per year)
- Bishop Auckland Food Festival 2013 Request for additional funding from D.C.C.
- Bishop Auckland Music Festival 2013 Request for additional funding from B.A. College.

After a lengthy discussion, members agreed that it was impossible to reduce the budget without detrimental effect to the services which the Town Council delivers.

**RECOMMENDED: (i)** That the rent increase from the Bishop Auckland Community Partnership be accepted.

- (ii) That Durham County Council be informed that, unfortunately, the Town Council cannot increase its sponsorship of the Bishop Auckland Food Festival for 2013 because of budgetary restrictions and an awareness of a further increase of the precept
- (iii) That Bishop Auckland College be informed that, unfortunately, the Town Council cannot increase its sponsorship of the Bishop Auckland Music & Arts Festival 2013 because of budgetary restrictions and an awareness of a further increase of the precept
- (iv) That, in view of the reduction of the workforce from Groundwork relating to the Town Council's Parks & Environmental Support Team, a new Service Delivery Agreement be entered into for the provision of one Supervisor and two apprentices for one day a week (Monday) at a cost of £8,200 p.a.
- (v) That, in view of this reduction of the workforce, the County Council be informed that the Town Council is unable to renew its Winter Maintenance Agreement.
- (vi) That the budget, as circulated, remain unaltered and the Second Draft V3 be submitted to full Council on 27<sup>th</sup> December for approval.

**Note:** Councillor June Lee requested that her disapproval to the percentage increase in the proposed budget be noted.
