FIN.50/16 MEDIUM TERM FINANCIAL PLAN 2016/17 – 2019/20 COUNCIL TAX 2017/18

Consideration was given to a report relating to the Medium Term Financial Plan (MTFP) 2016/17 – 2019/20 and Council Tax 2017/18. (For copy see file of Minutes).

Members noted that details of the Tax Base and the Local Council Tax Reduction Scheme (LCTR) Grant for 2017/18 had been reported to the Finance Committee at its meeting held on 6th December. (Minute No FIN.40/16 refers). The Tax Base (i.e. number of Band D equivalent properties) had risen by 55.2, increasing the Council Tax Yield by £2,198.62. However the LCTR Grant had reduced by £3,270. The net effect of this was that the precept would need to increase by £1,071.38 to achieve a stand still budget.

Consideration was given to the MTFP which had been revised to take into account information received from Durham County Council in relation to the Town Council's Council Tax Base and Local Council Tax Support Grant.

It was noted that following lobbying by NALC, County Associations and individual town and parish councils, including Bishop Auckland, the Government had advised that referendum principles would not be extended to town and parish council for 2017/18.

In considering budget requirements for 2017/18 Members were mindful of the development of a parish plan to respond to issues highlighted in recent consultations with local people. Whilst an action plan has not yet been fully developed, Members considered allocating a fund to help facilitate future projects associated with the issues raised.

Following detailed consideration of the MTFP and particularly budget requirements for 2017/18 the Committee recommended amendments to the MTFP detailed at Appendix 1 to the Minutes for consideration by Council
