FC27/21 <u>Apologies for absence -</u> To apologies were received. Apologies were received from Cllr K Eliot who had a prior commitment.

FC28/21 Declarations of interest – No declarations were given.

FC29/21 Public Participation - no members of the public were present.

FC30/21 Report of Town Clerk

- **FC30.1/21** Account Balances (Copy in file) were presented for all accounts and were noted. **Resolved:** the balances were noted and agreed.
- FC30.2.1/21 Bank Reconciliations at end of Quarter 2 & 3 were presented. Resolved: That the Bank Reconciliations were agreed and noted.

FC30.3/21 Spend Against Budget as at 31th December 2021 (Quarter 3) – and updated position on cost codes were given. Some areas hand minimal over spend due to the Council still adjusting to owning its own building, and there would be underspend in other areas to compensate for this. The building still is in need of some fixtures and fittings, with some furniture and meeting equipment needed to make the rooms useable. Members were advised that the Pay Award 2021-22 had just been nationally agreed, therefore the back pay would be owing till the 1st April. This had been planned for in budgets for 2021-22 and into 2022-23, as well as NI increases. Copy of report in file.

That looking ahead for 2022-23 that the Kingsway Building should be surveyed and appraised to ensure that the building is appropriately insured etc. Therefore the Clerk to speak with the insurer and instruct their approved surveyor to undertake this work.

That the Clerk price the raining needed furniture and equipment and circulate prices to Committee members and Chair of Accommodation for approval provided the costs are within the allocated budget. To be included are two additional meeting tables, extra conferencing chairs, side table and lectern, cups and glasses and office chairs for staff.

- Girls Friendly Society That a separate application should be sumitted for the alternative project which they wish to run, and that the initial part of the award be paid in line with original agreement only.
