# TC.111/15 DECLARATIONS OF INTEREST

# TC.112/15 WANNASEE FESTIVAL 2016

John Brennan and Paul Watson were in attendance to update Members on preparations for the 2016 Wannasee Festival.

Members noted that attendance had increased from the previous year in line with predictions that the Festival would become established over the initial three to four year period.

Members also noted the financial appraisal for 2015, together with likely costs for 2016. It was acknowledged that the financial support from the Town Council would be required in line with original projections.

Discussion took place with regard to the line-up for the 2016 Festival, together with outline arrangements for a civic event which was planned to take place at the Festival on Saturday.28<sup>th</sup> May 2016.

During discussions relating to the planned civic event it was noted that this would take place only four days after the election of the Mayor for 2016/17, which would not allow sufficient time for the newly elected Mayor to issue invitations and make other necessary arrangements. It was therefore suggested that the date of the Annual Meeting be changed to 31<sup>st</sup> May 2016, which would permit arrangements to be made for the current Mayor to hold a civic event at the Festival.

# TC.119/15 APPOINTMENT TO PLANNING COMMITTEE

Members noted that Councillors Race had resigned from the Planning Committee.

# TC.120/15 COUNCIL TAX 2016/17, MEDIUM TERM FINANCIAL PLAN 2015/16 – 2017/18 Consideration was given to the Medium Term Financial Plan 2015/16 – 2017/18 and in particular the proposed budget for 2016/17.

It was noted that in addition to inflationary pressures the Council's funding was also vulnerable to the effects of the Localisation of Council Tax Support regime which had the unintended consequence of reducing the Town Council's Tax Base, thereby reducing the ability to raise revenue.

The Government had made a grant available, however this did not make up the entire shortfall. Durham County Council had informed local councils that the allocation would reduce year on year in line with the reduction of revenue grant paid by the Government to it. Grant forecasted up to 2017/18 was included in the MTFP.

In addition, it was noted that the Secretary of State's powers to impose a referendum on principal councils where increases in Council Tax were above a certain level, may be extended to local councils. This would limit the Council's ability to deliver additional services. An announcement had not yet been made, however indications were that if this regime was imposed on local councils it may only apply to those Parish/Town Council that levy a Council Tax above the level of the smallest district councils, i.e. around £160 - £170 (Band D). An announcement was not expected until mid February, however Durham County Council had requested notification of local councils precepts by no later than 31<sup>st</sup> January 2016.

Bishop Auckland Town Council would not be affected if the referendum regime was extended as anticipated. However any announcement by the Secretary of State would

Signed: ..... Town Mayor be reported to Members and the Council Tax and the precept would be revisited if necessary.

The Finance Committee had considered the MTFP, incorporating budget proposals for 2016/17 at its meetings held on 1<sup>st</sup> December 2015. All Members had been invited to the meeting to participate in the preparation of budget proposals.

Detailed consideration was given to the Finance Committee's proposals, together with proposals to restrict the increase to Council Tax to £1.80 (4.73%), which would result in a Council Tax of £39.83 (Band D).

- **RESOLVED:** 1. That the Council's budget for 2016/17 be set at £192,427, resulting in a precept of £160,411 equivalent to a Band D Council Tax of £39.83 representing increase of £1.80 (4.7%) over the previous year.
