# Bishop Auckland Town Council Pigeon Keeping Policy

## 1. Purpose and Scope

This policy outlines the conditions under which tenants may keep pigeons on allotment sites managed by Bishop Auckland Town Council. It applies to all allotment tenants and is designed to ensure responsible pigeon keeping, safeguard animal welfare, and prevent nuisance.

#### 2. Permitted Conditions

- Tenants must apply for written permission before keeping pigeons.
- Only domestic pigeons (e.g. racing or fancy breeds) are permitted.
- Maximum of 50 pigeons per approved plot.
- No breeding or commercial activity is allowed.
- Pigeons must be kept in a secure structure, such as a loft or aviary (A Structure Application form is required).
- The Tenant is responsible for any such structure to keep pigeons; this includes the materials, construction and any repairs or associated maintenance required.
- The Tenant is responsible for the dismantling and removal of all structures and materials at the end of their tenancy.

#### 3. Welfare Standards

Tenants must comply with the Animal Welfare Act 2006 and ensure the Five Freedoms:

- 1. Freedom from hunger and thirst
- 2. Freedom from discomfort
- 3. Freedom from pain, injury or disease
- 4. Freedom to express normal behavior
- 5. Freedom from fear and distress

Lofts must be weatherproof, ventilated, and cleaned regularly. Pigeons must have access to clean water and appropriate feed.

## 4. Application Process

- Tenants must submit a written application to the Council.
- The Allotments Officer will inspect the site before approval.
- Approved tenants will receive written confirmation and conditions.
- Permission is subject to annual review.

## 5. Nuisance Management

Tenants must ensure pigeons do not cause nuisance to other allotment users or nearby residents. This includes:

- Noise control
- Odour management
- Vermin prevention
- Waste disposal

Complaints will be investigated and may result in revocation of permission.

#### 6. Enforcement Procedures

- The Council reserves the right to inspect pigeon facilities at any time.
- Breaches of this policy may result in written warnings, removal of pigeons, or termination of tenancy.
- Tenants may appeal enforcement decisions in writing to the Town Clerk.

# **Animal and Plant Health Agency (APHA)**

In addition to this Council Policy, the Tenant must also register their birds with the <u>Animal and Plant Health</u> <u>Agency (APHA)</u>.

This is the Tenants responsibility and you must register with APHA within one month of keeping poultry or other captive birds at any premises in England or Wales. This includes any birds you keep as pets. You will be breaking the law if you do register your birds with APHA.
