The Chairman advises members of the Council and the public that the meeting or part of the meeting may be recorded by audio and may be by video.

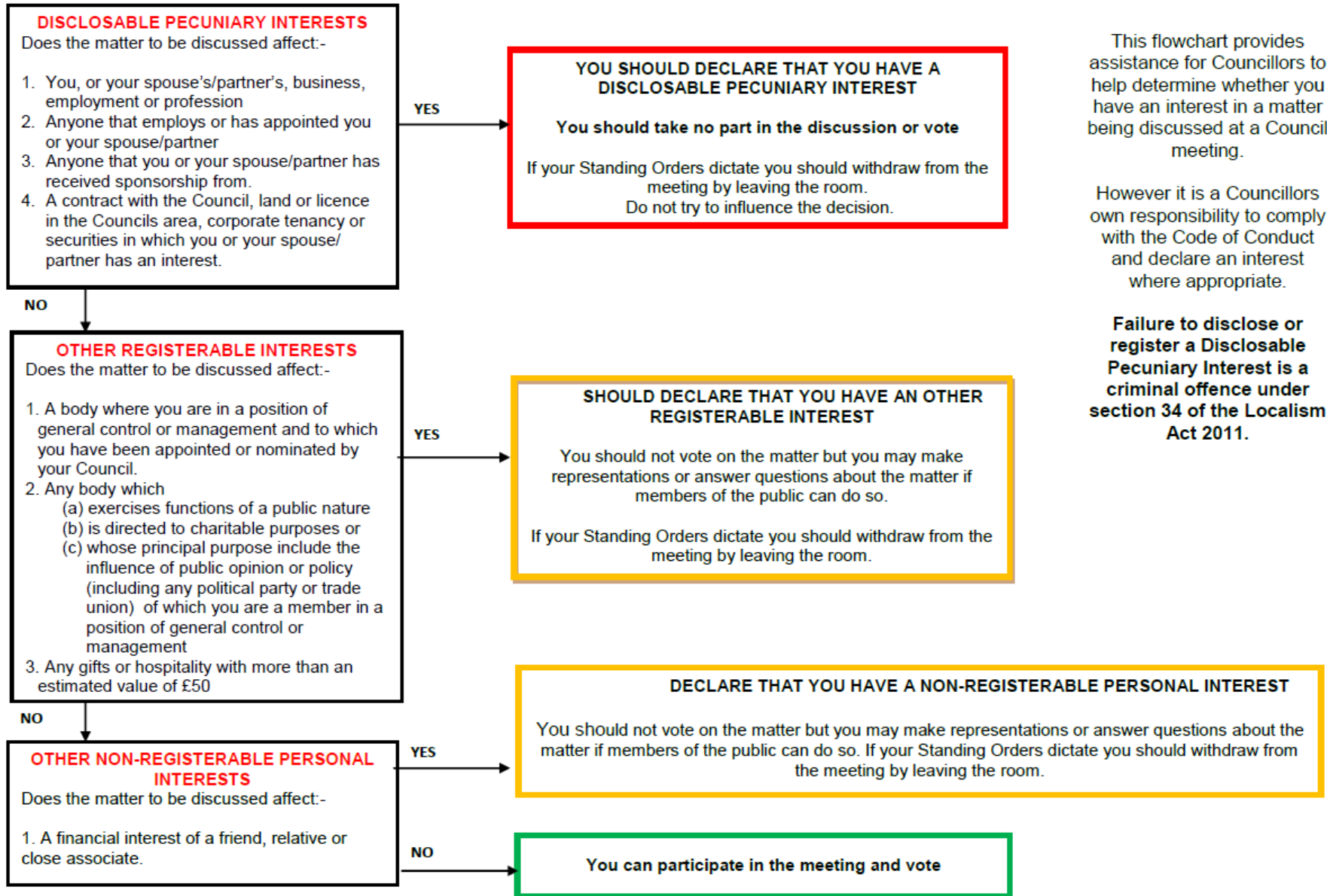
