# **Bishop Auckland Town Council**

TC 72.0/2021 Agree Notice of Motion to call the meeting to be held on 9<sup>th</sup> November 2021. Due to a postal issue only the agenda had only been received electronically and not in hard copy format. Members agreed to hold the meeting and just defer the Minutes of previous meetings and correspondence.

## TC 73.0/21 Apologies

Apologies were received and accepted from Cllr Balmer-Howison, as he was delayed with work.

TC 74.0/21 Declarations of Interest – No Declarations were received.

TC 75.0/21 Minutes & Matters Arising - this item was deferred due to the issue with the Meeting Papers not arriving.

TC 76.0/21 – Public Participation. There was one Member of the Public but they didn't wish to speak on any matter at this time.

### TC 77.0/21 – Reports

Date:

TC 77.1/21 – Jill Wood from DCC provided feedback on the recent Bishop Auckland Food Festival which had been held at the beginning of October after being delayed from earlier in the year due to Covid. The Town Council had supported this event. There were 21k visitors over the weekend. Layouts were changed to accommodate COVID changes, they will be keeping the new model for 2022. The new cultural elements of street theatre etc. were successful and will be continued in the future. Apologies were given regarding some issues with Coms for the BATC inputs on the weekend, these have been flagged and agreement was given to work closely together for 2022 to ensure that these issues don't happen again.

TC 77.2/21 – Acting Inspector Peter Lonsdale introduced himself to the meeting and explained that he had been in the role of Acting Inspector for Bishop Auckland since late 2020, however had he had previous experience working in the town as Beat cop in Woodhouse Close. He provided an overall summary of what is going on in the area from a policing perspective, and confirmed the awareness that ASB is a town wide issue which they are working to tackle but it takes a partnership approach. PACT meeting were being reinstated in areas where they worked successfully and alternative online engagement is being looked at for others. Members offered to help circulate meeting dates etc.

Questions were answered from members relating to

- Off Road Bikes Confirmed that it is an issue of ASB its hard to target due to lack of information and willingness to supply information but Operation Endurance is addressing this and there are pre Christmas Campaigns to address this.
- Puppy Farms it was theft of pets, the market has reduced following lock down for theft and puppy farms, DCC are the lead agency on puppy farms, but again intelligence is always needed and penalties are relatively low so unfortunately doesn't put people off.
- **Drugs** yes concerns of the Cannabis farms and Class A use/ dealing. There have been several successful raids, on Kingsway, St Peters Church Princes street etc. always need as much intelligence as possible and they are working constantly on things behind the scenes.
- ASB tackling it as a holistic issue, making parents aware and making whole families take responsibility for those causing the problems. Working with DCC and other partners to tackle the causes and put in stronger and wider sanctions.
- Kynren Fireworks issues with parking Acknowledged that there were lots of cars in town and lots parked badly, but it was for a couple of hours and as long as they weren't causing a dangerous situation they would be left. Bollards would be used on dangerous spots in the future and would be encouraging the organizer to work with the police and liaise with them earlier to ensure that support is available and alternatives are available for parking.

**TC 77.3/21** Local Heritage List – Georgia Cundick, Heritage Listings Outreach Officer from Durham County Council explained what the project as about and whilst a national scheme Bishop Auckland had been selected to be a pilot area. The list seeks to detail all of the assets which don't fall within Grade, 1,2 listed status but still form key parts of the history of the area.

**Resolved:** that the list members have pulled together be submitted and feedback will follow.

TC 77.4/21 Mayors Report - Mayor had held the Mayor at Home event — afternoon Tea at Fifties Tea room with 16 other mayors present Mayor had attended the Food Festival in Bishop Auckland. Mayor Had also attended the Bridge Creative Halloween Disco for service users. Details of Mayors Fundraising would be reported to the Finance Committee on a regular basis.

**TC 77.5/21** Durham County Council by Cllr Zair advised that the 2025 Culture bid was now live. The weekly updates were circulated to Member, and that the new administration continued to question previous decisions. Wifi Data on footfall was shared however it is known that not all of the receptors are working accurately so the data is not seen as correct at present.

i. AS part of the update Durham County Council Joanne Howey had submitted a proposal to the Council regarding revitalisation of the Town Rec. Herself and Cllr Hunt, were looking to submit the proposal to the AAP Town and villages revitalisation fund

Resolved: Members agreed whilst they aren't opposed to redevelopment and revitalisation of the Town Rec, but further consideration needs to be given to some of the proposals with wider partner engagement and some proposals could cause issues for neighbouring residents etc and given the staff shortages the council were not currently in the position to take the lead for this project at the moment.
